4a (Code:) (Expenses \$ 153,257. including grants of \$) (Revenue \$) FACILITY OPERATIONS - FACILITY MANAGEMENT HAS BEEN A MAJOR RESPONSIBILITY FOR ARTS PLACE, INC. SINCE 1983. ARTS PLACE OPERATES THREE COMMUNITY ARTS FACILITIES. THESE FACILITIES ARE LOCATED AS FOLLOWS:

JAY COUNTY - THE JAY COUNTY CAMPUS WAS BEGUN THROUGH THE 1983 ACQUISITION OF A 1935 STRUCTURE ORIGINALLY CONSTRUCTED AS AN AUTO DEALERSHIP. THROUGH A \$500,000 CAPITAL CAMPAIGN THE STRUCTURE WAS CONVERTED INTO AN ARTS CENTER. SINCE THAT TIME, ARTS PLACE HAS CONDUCTED TWO ADDITIONAL CAPITAL CAMPAIGNS. IN 2000 A \$2.9 MILLION PROJECT NEARLY TRIPLED THE SPACE OF THE ORIGINAL STRUCTURE TO ABOUT 21,000 SQUARE FEET, ADDED AN ARTS PARK, AS WELL AS TWO PARKING LOTS.

INSPIRED BY THE MUSIC SETTLEMENT MOVEMENT, ARTS PLACE BEGAN THIS MUSIC EDUCATION PROGRAM IN 1983. INDIVIDUAL AND GROUP INSTRUCTION IS AVAILABLE IN BRASS, GUITAR, HARP, PERCUSSION, PIANO, ORCHESTRAL STRINGS, WOODWINDS, AND VOICE. ENSEMBLES CONDUCTED INCLUDE PERCUSSION, BRASS, ORCHESTRAL STRINGS, FLUTE, AS WELL AS THE JAY COUNTY COMMUNITY BAND AND THE COMMUNITY CHOIR, WHICH IS CALLED A CHOURED TASTE. DUE TO THE PANDEMIC, MOST ENSEMBLES WERE NOT OFFERED DURING THE FISCAL YEAR, WHILE IN-PERSON PRIVATE LESSONS WERE CONDUCTED WITH SOCIAL DISTANCING, MASKS, AND SIGNIFICANT HYGIENE PROTOCOLS FOR STUDENTS AND FACULTY. INTRODUCTORY MUSIC INSTRUCTION FOR PRESCHOOLERS ONCE AGAIN THROUGH THE FIRST STEPS CLASSES IN THE SUMMER

ARTS IN THE PARKS - THIS POPULAR PROGRAM WAS LAUNCHED IN 1977 AND CONTINUES TO PROVIDE ACCESS TO THE ARTS FOR CHILDREN DURING THE SUMMER MONTHS. OVER 15,000 CHILDREN HAVE PARTICIPATED IN THE PROGRAM SINCE ITS INCEPTION. THE WORKSHOPS ARE DESIGNED FOR CHILDREN AGES SIX THROUGH TWELVE AND PROVIDE INTENSIVE INTRODUCTIONS TO SPECIFIC ART-FORM MEDIUMS. WORKSHOPS ARE TYPICALLY LED BY PROFESSIONAL ARTISTS AND ARTS EDUCATORS, WHO ARE REFERRED TO AS TEACHING ARTISTS. IN JUNE 2021 THE PROGRAM INCLUDED THIRTEEN COMMUNITIES IN FIVE COUNTIES IN INDIANA AND OHIO.
