ELIGIBILITY

Works in any 2D medium, including photography qualify. (No 3D at this time.) All works must be original and must be ready to exhibit (i.e. framed and ready to hang/no saw tooth hangers) and completed within the last five years. Maximum size limit of 4'x4'. Must be a resident of Indiana

INSURANCE

All works will be insured from their delivery to their departure from the BCAC. Please provide value of artwork, if not for sale.

SALES AND COPYRIGHTS

Sales are encouraged. A 30% commission will be charge on all works purchased. Your entry grants permission to photograph your work to use for promotional or educational purposes only. Artists who are awarded the cash prizes grant the right for the BCAC to photograph the artist with his/her work. Artwork that is purchased must remain throughout the duration of the exhibition.

JUROR - STEPHEN EDWARDS

Stephen is a member of several national and local level art organizations which include the American Watercolor Society, National Watercolor Society, Hoosier Salon (Signature Member), Indiana Artists Club, Brown County Artist Association, Indiana Heritage Arts, Pennsylvania Watercolor Society (Signature member), Illinois Watercolor Society, Philadelphia Watercolor Society (Signature Member), Kentucky Watercolor Society, Bloomington Watercolor Society (Signature member), and the Art Association of Madison County. He is also an elected member of the Mondial Art Academia of France where he was given the title Knight Academician after receiving the Silver Medal for aqua-media in the 2020 international exhibit held in France. Stephen also is the co-founder of the Watercolor Society of Indiana as well as a Signature member of that group.

He has won numerous awards in many exhibits, more recently the Dorothy Schulz Englehart Award in the Watercolor Society of Indiana 2020 Juried Exhibit at the Indianapolis Museum of Art, the Fredrick Vance Award from the Brown County Art Gallery in 2020, Best Of Show Indiana Artists Club at the Richmond Museum 2021, First Place Award of Merit In Watercolor at the 97th Annual Hoosier Salon 2021, and the National Watercolor Society Award Of Excellence in Watermedia at the Philadelphia Watercolor Society's 121st Annual Exhibition.
