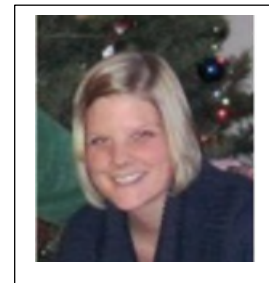

Tiffany Grace Abner Music Scholarship



Established by Tiffany's home church, the Redeemer Lutheran Church, Bryant, Indiana, in the Adams County Community Foundation (ACCF) in memory of Tiffany Abner. This fund is a partnership with the ACCF and Arts Place for a scholarship program with Arts Place in memory of Tiffany Grace Abner. The scholarship fund will help students from Adams County and Jay County in meeting the cost of instruction through the Arts Place MusicWorks program.

The Tiffany Grace Abner Scholarship Fund was established at the Adams County Community Foundation in memory of this impressive young woman who was very active with the Redeemer Lutheran Church in Bryant, Indiana and the Adams and Jay County communities.

Tiffany passed away from injuries sustained from an auto accident in December 2013. Born in St. Paul, Minnesota, she was the daughter of David and Ruth (Schepman) Thorsell. Tiffany married Robert Abner July 16, 2011. Her husband was pastor of Redeemer Lutheran Church in Bryant, Indiana when this scholarship was established. Tiffany was a school psychologist for Mississinewa School Systems and was a member of Redeemer Lutheran Church and the National Association of School Psychologists. Musically, Tiffany was an avid violinist before moving to Bryant. Shortly thereafter, Tiffany enrolled in the Arts Place MusicWorks program to expand her skills by studying cello. This fund will be an annual tribute to remember Tiffany, her talents, and her love of music.

The scholarship will be available to multiple students from Adams County and Jay County, providing fee support for each student. While financial need may be considered as a factor, dedication to music study and enthusiasm for music will be the primary considerations.

While there is no deadline for application for this scholarship program, eligible students are encouraged to apply upon registering at Arts Place for music lessons. When the qualified students have been selected, the scholarship opportunities expire for that school year.

First come-first served. There is no deadline / due date for application for the Tiffany Grace Abner Scholarship. Students are encouraged to apply upon registering for music classes at Arts Place, Portland, Indiana. When the appropriate number of qualified students have been selected, the scholarship opportunities for this program expires for that academic school year.
